

- VALID FOR MULTIPLE TRIPS UP TO 90,000 POUNDS.
- NOT VALID FOR OVER-DIMENSIONAL LOADS.
- MAXIMUM WEIGHT SHALL NOT EXCEED 38,000 POUNDS FOR ANY ONE TANDEM AXLE OR 56,400 POUNDS FOR ANY ONE TRI-AXLE.
- VEHICLES OR COMBINATION OF VEHICLES THAT EXCEED THESE WEIGHT LIMITS SHALL OBTAIN A SINGLE-TRIP PERMIT.
- SEE ATTACHED LIST FOR BRIDGES / ROADS TO BE RESTRICTED OR EXCLUDED FROM ANNUAL OCEAN BORNE MOVEMENT.
- PORT AUTHORITY OF NY AND NJ BRIDGE AND TUNNEL MOVES ARE LIMITED TO SPECIFIC PERMITTABLE DIMENSIONS. TO MOVE ON THE OUTERBRIDGES BRIDGE FIRST CONTACT (718) 390-2505. TO MOVE ON THE GOETHALS BRIDGE FIRST CONTACT (718) 390-2502. TO MOVE ON THE GEORGE WASHINGTON BRIDGE FIRST CONTACT (201) 346-4100. TO MOVE IN THE LINCOLN TUNNEL FIRST CONTACT (201) 617-8115. - NO TRUCK TRAFFIC IS ALLOWED ON THE PALISADES INTERSTATE PARKWAY, ON THE PULASKI SKYWAY, OR ON THE GARDEN STATE PARKWAY NORTH OF EXIT 105.
- AS PER N.J.S.A 39:3-82 AND/OR 39:4-27, THE MAXIMUM GROSS WEIGHT OF THE COMBINATION OF VEHICLE AND LOAD SHALL BE LIMITED TO EIGHT HUNDRED POUNDS FOR EACH INCH IN WIDTH OF TIRE ON ANY ONE WHEEL. THIS PERMIT WILL BE CONSIDERED INVALID IF THIS WEIGHT LIMIT IS EXCEEDED.
- OVERWEIGHT AND WIDE LOAD VEHICLES USING WALT WHITMAN BRIDGE WILL NOT BE PERMITTED TO WAIT FOR A DRPA POLICE ESCORT IN THE GORE AREA OF I-76WB/I-676NB. ALL OVERWEIGHT AND WIDE LOAD PERMIT VEHICLES WILL NEED TO TRAVEL I 676 NB TO EXIT3 FOR MORGAN BLVD, RE-ENTER I 676 SB AT MORGAN BLVD, THEN TAKE EXIT 2 FOR WALT WHITMAN BRIDGE I 76 WB AND WAIT IN THE PULL-OFF AREA ON THAT RAMP FOR A DRPA POLICE ESCORT.
